Graceland University – Lamoni, Iowa Registration – Nauvoo, Illinois August 4, 2016

Thursday, August 4, the train group was one hour and 30 minutes delayed. This created a few interesting problems and Frances Orton needed to text Cindi Wilson at Liberty Hall and had also stay in touch with Graceland University about the groups progress.

Then as we were departing the train, one of the family members fell coming down Amtrak's stairs. He was unable to walk. He had some concerns because he is prone to blood clots and he was struggling with pain. The Amtrak staff put him in a wheelchair and brought him to the station. There it was decided that he should be looked at by medical care. Their luggage was taken off the bus just after everyone else had loaded the buses. EMT's were called and arrangements made for someone to give them a ride to Nauvoo to meet up with the group the next day. The thinking was that they would be at the hospital throughout the day. The EMT's arrived and looked at him before our busses had left the station. The EMT's felt he could make the trip and after agreement from the injured and loading their luggage back on the bus, the group was on the way.

The Smiths and their two buses pulled into Lamoni, home to Graceland University, at 11:00 am. Graceland University is a private, four-year liberal arts university sponsored by Community of Christ. The school was founded in 1895.



The University staff brought a golf cart to meet the busses and this allowed a way for the injured man to get to the Floyd M. McDowell Commons where a nice hot breakfast was served.

Her organization made it possible to get 112 people get through a meal quickly.

ALEXANDER HALE SMITH

b. 1838

d. 1909... plot 801

Liberty link: younger brother to Joseph Smith III

During the interim period between the murder of Joseph Smith Jr in 1844 until the beginnings of the Reorganization in 1860, the 4 sons of the Prophet were ambivalent toward the 'faith'. When Joseph III polled his brothers regarding his assuming the reins of the RLDS, only David was in favor. Frederick and Alexander disagreed. Perhaps their father's persecution and death played too harsh a burden to carry forward.

And yet, with Frederick's untimely death in 1862, the fact that his brother had not been baptized disturbed Alexander greatly. Through prayer and revelation he became aware that in time his lost brother's baptism would be secured. Moreover, Alexander's mission in his own life was realized. He soon joined Joseph III,s new church, being baptized in Nauvoo in 1862, and devoted his life to missionary work.

Rising through the RLDS hierarchy, he traveled extensively west to include California, western Canada and Mexico - preaching, establishing congregations, and overseeing priesthood leadership. Further on, there were trips to Australia, the South Seas, New York and Boston, not to fail to mention sharp dangerous debates over polygamy in Utah.

David, in a poem, called himself and his older brothers Joseph III and Alexander - the Three Pillars of the RLDS church.

A life's work included being an apostle and patriarch within the RLDS -also serving on the Board of Directors of Graceland College. Born and raised in the old Mansion House in Nauvoo, Alexander was, throughout his life, an avid outdoor sportsman, a crack shot, and a carpenter by trade. He died in Nauvoo while visiting in 1909 – 47 years devoted to the faith.

MARY AUDENTIA SMITH ANDERSON

b. 1872 Plano, Ill d. 1963 plot 785

Liberty link: daughter of Joseph lll

Mary was Joseph and Bertha's second child who in 1881 at the age of 9 traveled west with her family to Liberty Hall in Lamoni.

Multi-talented from a young age, the list of her accomplishments is extraordinary.

At 12 Mary was the church organist. She headed the department of music at Graceland College.

She served as choir director at the Old Stone Church. With Vida Elizabeth Smith she wrote a favorite hymn, The Old, Old, Path along with composing 17 others. She wrote and edited two ambitious literary works: a 720 page genealogical study entitled, The Ancestry and Posterity of Joseph Smith Jr. and Emma Hale (1929) and more importantly, Mary edited her father's detailed autobiography, The Memoirs of President Joseph Smith Ill 1832-1914.

Perhaps in conjunction with her Ancestry book, Mary was an active member in many historical societies to include The Daughters of the American Revolution, The Mayflower Society, the Daughters of 1812 and others.

She married Benjamin Anderson of Lamoni in 1891. They had 7 children - 4 of whom grew to adulthood.

With the heartbreaking death of her mother in a horse and buggy accident in 1896, she and Ben plus the children moved back into Liberty Hall for a time to assist her father and help care for the family. After the death of her father in Independence in 1915, the Andersons resided in Omaha until 1959.

Mary and Ben celebrated their golden wedding anniversary in 1941.



Heman C. Smith and Vida Elizabeth Smith

Vida is daughter of Alexander Hale Smith. She married Heman Smith. Her second marriage was to Jim Yates. Her daughter was Inez Smith Davis, who wrote "The Story of the Church" which is a very complex history of the restoration, one of the most valuable documented works done on the early RLDS history.

Heman Smith was a grandson of Lyman Wight. Lyman had moved to Texas and the RLDS found Heman in California and converted him to the RLDS church. He he became the chief historian for the RLDS church.

DAVID HYRUM SMITH

b. 1844 (Nauvoo)d. 1904 ... plot 443

Liberty link: Youngest brother of Joseph III

He was the last child born to the Prophet Joseph Smith Jr. and his wife Emma Hale. Note the birth year - 1844. At the time of the Carthage murders, Emma was pregnant and gave birth five months later to David Hyrum; a life that both began and ended in affliction.

There is a striking photograph of David coming of age at 18. Tall, slender and handsome, he appears like a young Lord Bryon. And why not. He professed an artistic gift: a poet, writer, painter and composer, blessed with a singing voice the 'saints' affectionately called, 'the sweet singer of Israel'. Many early RLDS hymns are attributed to David. One of his paintings hangs above the mantle in Liberty Hall.

To the church as a whole, he was the 'son of promise'; charismatic, a lightning rod, carrying a deportment that reminded many of his father, the Prophet. A missionary early on, his was a ministry of kindness, wit, and humor. In 1870 he married Clara Charlotte Hartshorn. A son, Elbert, was born a year later. With his oldest brother Joseph firmly at

the helm of the Reorganization, with David ordained second counselor to the president, never, perhaps, had the future of the young church seemed brighter.

But with his blessed gifts there came a sensitive fragile nature. A second missionary trip to Utah in 1872 proved ruinous. In retrospect, with a new wife and child back in Plano, the yearlong ministry west was ill conceived. David's mission was met at times with LDS defiance and open hostility. He sought testimony of those that knew his father and the role the Prophet may have played regarding polygamy. Stress and agitation grew. There was an engagement with spiritualism and séance. He became ill with fever. The end result proved too heavy a burden. His health and heart were broken. Upon returning to Plano, the affable, energetic David who left was far removed from the troubled David that returned.

As time wore on, melancholic dementia set in followed by delusion. His once adoring congregation now stood apart concerned and somewhat fearful. There were fits of temper and violence. At last in early 1877 with the elders urging, Joseph III had David committed to a hospital for the insane in northern Illinois. Reason and rational never returned and there he remained for the final 27 years of his life.

In 1904, the Joseph III family still resided at Liberty Hall. They brought David's body to Lamoni for burial at Rose Hill.

Another problem that developed with the train delay was the need to get family members helping with the reunion registration to Nauvoo in time. Lach & Christin Mackay and John & Anina Luff came to the rescue. Lach loaded the needed luggage and registration materials in his car. Then John & Anina drove Bryan, Anne, and Frances Orton to Nauvoo allowing registration to go on as planned.


During the bus ride from Omaha to Lamoni, Frances had contacted several people (on stand-by) by text and phone when cell coverage was available to arrange pick up of the needed supplies and prepare things at the Rehearsal Hall. Kim Smith and Bryan Davis picked up the nametags and printed materials being held at the Joseph Smith Historic Sites Visitors Center. They also picked up the ordered treat for the evening reunion meeting from Nauvoo Fudge. Daniel & Kris Patrick met Elder Singer at the Nauvoo Pageant Rehearsal Hall to do a required walk-through of the building and pick up the key. The Patrick's were instrumental in setting up and preparing for

registration. Don and Laura Blanchard also kept registration on track. Having all these people in Nauvoo and ready to go made all the difference. Debbie Nelson and her daughter Courtney came with two cousins Marlene Stowe and Ann Haws-Alleman and took care of all the t-shirt sales.

Registration was able to begin at the scheduled 4:00 pm time at the Rehearsal Hall in Nauvoo. Several tables with the nametag trays were spread across the lobby so that as people entered the building they could pick up their nametags and program. Smith Family member, Mariana Allan, used her wonderful skills with the t-shirt and reunion logo design
